### What We're Doing to Improve Accessibility


We plan to fix all existing issues wherever possible by 31st August 2021 and to continue to monitor and improve the system throughout its life.

This website was last tested on 20th August 2020. The test was carried out by Cognizant. We used a risk-based approach to identify the 12 most-used and areas and areas with most important functionality within the system to decide on a sample of pages to test.
